
I am directed to say that the State Government has "No Objection" for affiliation of D.A.V Collegiate School, Lacchipur Kathua to run its classes 1<sup>st</sup> to 5<sup>th</sup> with Central Board of School Education subject to the fulfillment of following conditions:-

1. 50% or more of its total number of students are children of Central government employees, defence personnel or other people whose services are transferable to places outside the State, people who migrate in connection with business or services in private sector.
2. reserve a minimum of 10% seats in all for children of economically backward persons every year and allow them free-ship. The list of such children shall be provided to the department of Education every year in the beginning of the session;
3. gives due consideration to qualified State Subjects while appointing teaching and non-teaching persons;
4. should have at least two members representing the Department of Education, Government of Jammu and Kashmir on its Managing Committee. The members will be nominated by the Education Department.
5. undertake to make arrangements for teaching of mother tongue(s) of the children;
6. implement the three language formula;
7. follow a contextualized curriculum which has local culture, traditions and ethos incorporated in it;
8. registration of trust;
9. the list of persons in the Management of the trust;
10. permission, if any, granted by the Director School Education, Jammu for running the school upto 5<sup>th</sup> class;
11. details of infrastructure, assets etc available with the trust; and
12. undertakes to follow instructions which the State Government may issue from time to time for ensuring quality education in the State.
13. possess infrastructures as prescribed in SRO-123 dated 18<sup>th</sup> March, 2010.
14. possess the drinking water and toilet facility for students & fire extinguisher equipments.

The school shall be opened to the inspection by the Director, School Education Jammu or any other officer authorized by the School Education Department.

Further, NOC is granted purely on provisional basis, if the management fail to fulfill the above said conditions within a period of three months NOC granted shall be treated as withdrawn.



- The School management shall follow all the orders pertaining to schools issued by the Govt. from time to time and the Govt, reserves the right to cancel or suspend registration if found indulging in activities in contravention to Court Orders/ directions.

The Chief Education Officer, Kathua shall ensure that aforesaid conditions are fulfilled and complied by the Principal/School Management within three months failing which permission accorded shall cease to exist further and shall be deemed to have been withdrawn ab-initio.

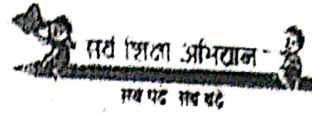



Dear Sir,

The inspection of above said school was got carried out by the inspecting officer of this department and found that the management has installed First Aid Fire Extinguishers, One Hose Reel Hose, Fire Point and underground water storage tank in their school premises. As such, the management can proceed ahead for running the school. The school is approachable for fire appliances in case of any emergency. However the management is advised to adopt the following fire safety measures in letter and spirit:-

1. Hose Reel Hoses as per BIS specifications should be provided at each floor of the school building. The Hose Reel Hose should be kept at such a place in each floor where all sections of each floor are covered easily at the time of any emergency. A Fire Pump of desired capacity should be installed near underground water storage tank with dual electric supply for feeding the terrace tank.
2. First Aid Fire fighting system installed in the School building should be checked periodically. Staff and students should be fully trained in handling/ operating of fire fighting system installed in the School building. The management shall intimate the office of Assistant Director, Fire & Emergency Services Command Samba-Kathua after each quarter that the fire fighting equipments installed in the school are functioning.
3. No Hazardous material should be kept inside or outside of the School premises (especially LPG cylinder, Petrol and Diesel etc.). Any deviation found in this regard, the Fire Safety Certificate issued shall be treated withdrawn/cancelled.
4. The management of the school shall be wholly and solely responsible for keeping the fire fighting system in working condition 24x7 to face any eventuality, besides evacuation of its students and teachers in case of any fire incident.
5. The validity of this clearance shall remain enforce for one year and same needs to be renewed after checking of fire fighting system installed in the school (i.e. existing as well as proposed).






